



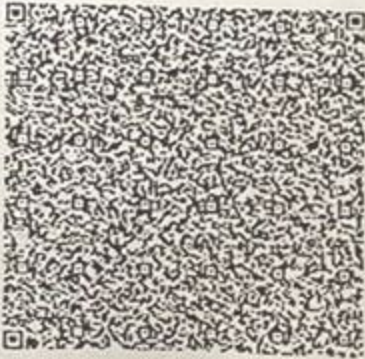

JOINT VENTURE AGREEMENT BETWEEN THE DELHI PUBLIC SCHOOL SOCIETY AND M/S. INDIAN OIL CORPORATION LIMITED

THIS AGREEMENT is entered between The Delhi Public School Society registered under the Societies Registration Act, 1860 with its registered office at The DPS Society Office, F-Block, East Of Kailash, New Delhi - 110065, hereinafter called "DPSS" (which expression shall include its successors and

assignees) on one part and M/s. Indian Oil Corporation Limited (Panipat Refinery), Panipat, Haryana, a company incorporated under the Companies Act, 1956 and having its registered office at G-9, Ali Yavar Jung Marg, Bandra (East), Mumbai - 400 0051, hereinafter referred to as 'IOCL' (which expression shall include its successors and assignees) of the other part.

The expressions 'DPSS' and 'IOCL' shall hereinafter be collectively referred to as 'PARTIES'

AND WHEREAS the parties hereto have jointly agreed to continue the existing Delhi Public School at Panipat Refinery Nagar, Panipat, Haryana, which had been established under Agreement dated 21st November 1997 between the parties and in supersession of all previous Agreements and as per the terms and conditions and in the manner as set out herein under.

NOW THIS AGREEMENT WITNESSETH and it is mutually agreed upon by and between the parties that: -


1. DPSS shall collaborate (provide academic & management support) with IOCL for continuation of the existing Delhi Public School at Panipat Refinery Nagar, Panipat, Haryana, (hereinafter referred to as 'the School') as an Educational Joint Venture.
2. Incidental to the arrangement between the parties, DPSS hereby permits and allows the IOCL to use the name Delhi Public School, its Logo and Motto as a means of identification for the school mentioned in clause-1 and not for any other purpose. The aforesaid limited usage of the name Delhi Public School, its Logo and Motto shall be without any obligation to pay (upon the IOCL) any consideration. It is further agreed that such usage is limited for the predetermined purpose and does not create any right, title or interest in favour of the IOCL on the exclusive intellectual property rights of DPSS. Such limited usage is permitted only until the validity of this Agreement and such usage may, however, be in conjunction with any other name that may be decided between DPSS and IOCL.
3. DPSS shall be at liberty to open more schools anywhere in the country or outside the country in collaboration with any other society / organisation or exclusively on its own. However in case DPS Society proposes to open a new school in close vicinity of existing DPS it shall decide the issue after consulting the promoters of the existing DPS.


